



Terms & Conditions

1. There may be some plus and minus on a account of k. m. to be run by every day Finally it would be adjusted at the end of every month after over all running of Vehicles shall be calculated 1500 km. per month.
2. Hiring charges shall be for 10 hours per day (i.e. from 9.15 am. to 7. 15 pm.) normally but may vary as per official requirement Extra working hours if any will be adjusted by giving off.
3. The Payment on account of extra mileage over and above shall be paid as per rate quoted by agency No. over time etc. will be paid extra other than the put in NIQ by Department and no. addition if any of agencies will be accepted.
4. The above rate shall be inclusive of fuel (Diesel / Petrol / CNG) Driver and other propelling charges including A.C. etc.
5. The firms is bound to provide well, maintained vehicle & registered with RTO, vehicle should be made available at short notice time any day. The vehicles have to park in EE (E), CCW, AIR, Civil Line Nagpur office campus to ensure this condition.
6. Driver Deployed should be well behaved and well versed with roads of Nagpur & out station and having valid License for Driving the Vehicle.
7. Vehicle and driver shall not be changed frequently on any occasion without prior intimation and permission of Competent Authority i.e. minimum two days before.
8. If the Vehicle misses any day and does not reach at duty point, then the deduction will be made at the rate of double the rate quoted by agency for per day.
9. The competent Authority has full right to terminate contracts if the service is not found satisfactory with a notice period of 15 days without assigning any reason.
10. The vehicle should be latest model if vehicle condition not found satisfactory the same should be changed by proper vehicle.
11. Loss and theft during the period of providing services will be dealt as per relevant rule for which 10 % of quoted amount will have to deposit as security deposit by the lowest agency within seven days from date of opening of notice inviting quotation and same will be released after successful completion of work.
12. The rates should be quoted including all taxes, over head & profit etc complete. Nothing extra shall be paid in whole year.

13. The supplier has to make some alternate arrangement of other vehicle in case of servicing /maintenance of original vehicle, the substitute vehicle should not be different from the list mentioned in the name of work of NIQ.
14. Kilometer inbuilt of taxi should always be in working condition and as per regulation of appropriate Transport Authority.
15. Income Tax / other Taxes will be deducted as per applicable rule. Nothing will be paid on account of increase of fuel charges and local taxes during the contract period. Rates should be including all taxes on over time etc. will be paid extra.
16. Daily meter reading will be recorded at time arrival and departure and maintenance of log book will be responsibility of agency.
17. The Vehicle should be Taxi registered for Nagpur Motor Licensing authority.
18. The Agency will submit the registration certificate of Taxi along with the quotation with held with the agency.
19. The Agency who does not full fill the above requirement will summarily be rejected.
20. The date of contract shall be effective and valid for one year as per office order.
21. The agency should be registered under GST Act and submit GST Registration Certificate.
22. In case vehicle goes outside Nagpur nothing would be paid extra for (journey expenses of Driver if any) other than night halt charges quoted per night.
23. The quotation should be submitted by the agencies in sealed cover address to the Executive Engineer (E), CCW, AIR, Nagpur on or before 21.12.2018 up to 3 00 pm. envelope should be super scribed that the "Quotation for Hiring of Vehicle.
24. Payment would be made on GST tax invoice. GST would be payable extra, as applicable.
