TERMS AND CONDITIONS:

- 1. The successful bidder/qualifying firm shall have to deposit a security amount of Rs. 10,000/- in the form of Term Deposit of one year drawn in favour of the firm/ contractor. SCOPE OF WORK

- The work comprises of servicing of 6 X 16 ton package type AC Plant, make Blue star, which mainly comprises of 6 nos of Indoor units and 18 nos of Outdoor unit.
- The details of the work comprises of general cleaning of the above mentioned units, by using conventional/ power cleaning methods.
 - a) Cleaning of filters, cleaning of the inlet and outlet Copper pipes, taking out of corrosion from the Copper pipes as well as inlet and outlet valves.
 - b) Checking and alignment of fan motor assemblies and capacitor checking, (If capacitor is found defective/ punctured or leaky the same needs to be replaced) in respect of all the 18 nos of outdoor units. In case of shaft repairs, the same needs to be repaired as per need basis.
 - c) Plugging of leakages, brazing of leakage points, pressure testing and flushing with nitrogen gas and minimum pressure stability test of 72 hours after vaccumization and gas charging.
 - d) Providing and fitting of new temperature sensors in all 6 indoor units, if existing ones have lost their sensitivity. Checking of all the sensor temperature cards for threshold settings.
 - e) Providing and fitting of dryer filters in 6 nos of Indoor units on actual requirement basis, if needed.
 - Replacement of Canvas mufflers/ cloth couplers, in case the same are torn out or punctured.
 - g) Replacement of bearings in blower assemblies of indoor units in case mechanical noise is prominent in blower motor assemblies. Mechanical alignment of blower assemblies of motor units. Greasing of blower units.
 - h) Firming, repacking and cleaning of ducts from Indoor units upto diffusers.
 - The company who shall undertake the servicing shall have to arrange all the materials/ implements/ charging gas (R-22) on complete job basis.

- 4. A performance guarantee of 10% of the final cost of servicing/ replacement of materials shall be with-held for period of 6 months from the billed amount and shall be released after successful performance of the AC Plant for a period of minimum 180 days.
