Terms and Conditions

1. <u>Duration of Operation</u>:

The technical facilities installed at Doordarshan Kendra, Srinagar and HPT, Shankracharya Hill are required to operate un-interrupted 24x7 throughout the year. In order to immediately attend reported faults in AVRs i.e. without any loss of time, the bidder must be Srinagar based service provider for the maintonance of AVRs on 24x7 basis.

2. Schedule of Work:

- i) The successful bidder is required to carry out scheduled maintenance of all AVRs under AMC as detailed in Annexure II:
- ii)Besides the scheduled preventive maintenance of the AVRs, the successful bidder will ensure proper functioning of all AVRs all the time. In case of any fault, the firm should immediately depute the service engineer for attending the fault.
- iii) The Non-Comprehensive AMC(labour charges only) includes repair/replacement of all parts of AVRs, electrical motors, windings, core transformers, control cards, relays, jumpers, connectors, switches, lugs, internal wiring, all type of meters installed on the AVRs and any other part of the AVR System.
- iv) The AMC is Non-Comprehensive type and Kendra will provide all the Spares for the Maintenance of three Servo Controlled AVR's.
- v) Smooth and in-interrupted operation of all AVRs is essential for seamless transmission and smooth production. The contractor is expected to provide the services as under:
- The Tenderer/Firm should be registered and have GST and PAN.
- b. The firm which will not attach mandatory documents at clause quoted on page No.1 of the tenderdocument, bids of such bidding Firms will not be considered for Price Bid opening.
- c. The contractor should depute trained and experienced service Engineers on site as and when required on 24x7 bases for immediate trouble diagnosis and rectification.
- d. The contractor should have sufficient stock of spare parts required for repair for providing prompt service to Doordarshan in case of emergency. Part replaced by the firm would be replenished by the Kendra.
- e. The contractor will carry out the maintenance schedules strictly under the supervision of AE/ADE/DDE/DE-in-charge without affecting the transmission and other activities and submit the detailed report of such maintenance works on the letter head of the firm duly signed by the service engineer and AE/ADE/DDE/DE-in-charge within 24 hours.
- f. All the tool and testing equipment's for maintaining the AVRs in perfect working condition at Doordarshan Kendra, Srinagar will be provided by the contractor.
- g. The contractor will take care of safety of his staff while they are working on any AVR and will provide them all safety gadgets. This office shall not be responsible for any mishaps/financial liability to the staff deployed by the contractor.

h. The AVRs have been installed in the protected and restricted area. The contractor shall provide the bio-data of his staff (supported by necessary documents if required)and obtain entry passes for them before putting them on duty. The conduct of contractor and of his personal shall be the sole responsibility of the contractor. The contractor and his staff shall observe the security and other rules in force while working in the premises of this Kendra and HPT Shankaracharya Hill Srinagar.

3. TIME SCHEDULE:

The faults reported should be attended immediately without any loss of time. After assessing the nature of fault the supervising officer or the authorized representative of the Deputy Director General (E) will give reasonable time schedule to the contractor for removing the fault/repairs. If the fault is not repaired within the allotted time, the penalty will be levied as decided by Deputy director General (E) and his decision in this regard will be final and non-negotiable.

4. Site Visit:

The prospective bidders may visit the site to inspect the AVRs before submitting tender from 1000Hrs to 1700 Hrs on working days after obtaining permission from Deputy director General (E) DDK Srinagar.

5. Premature termination of Contract:

The Deputy Director General (E), Doordarshan Kendra, Srinagar reserves the right to terminate the contract prematurely if the performance of the contractor is not found satisfactory.

- Deduction of GST etc. will be done as per standing Government rules. Necessary tax clearance certificate in the prescribed form issued by the assessing Authority concerned should be attached with the quotation.
- 7. As these AVRs are being used for feeding power supply to technical facilities, which are in operation on 24x7 basis, the successful bidder will have to render service on 24x7 basis as and when required, in addition to the schedule visits as detailed in the tender document.
- 8. The successful bidder will have to enter into an agreement with the department on Rs.100/-non judicial stamp paper for Non-comprehensive annual maintenance of Threeno.s Servo controlled AVRs mentioned on page no. 1.
- 9. In case there is any sort of loss or damage to the Government property due to the negligence of the firm, the same will have to be compensated and made good by the firm.
- 10. The extra expenditure, if any, the department has to incur due to deficiency of maintenance services rendered by the firm, either in the form of spare parts provided by Doordarshanfor maintenance or in the form of services taken by Doordarshanfrom any other firm, will have to be borne by the contractorand the expenditure so incurred, will be adjusted against the amount due to the contractor.
- 11. The AMC is for the period of 12 months from the date of signing the agreement besides the scheduled and regular service of all AVRs; the successful bidder ensurestheir proper functioning. In case of any fault, the firm should immediately depute the service engineer for attending the fault. The spare parts required for repair will be provided by the Kendra. However, the bidders may offer the rates of frequently required spare parts of the original equipments manufactures. The necessary cooling oil, relays, timers etcl will be supplied by the Kendra.

- 12. The contractor will be bound by the rates quoted by him and shall have no right to askfor enhancement of rates for service beyond what he had quoted in his quotation till the time the contract remains in force.
- 13. The contract of the successful tenderer will remain in force a period of one year from the date he comes into agreement with the department or for an extended period which will be on the basis of mutual agreement.
- 14. The tenderer must have past experience of at least three years of maintenance of such type of AVRs. The bidder should have experience of providing maintenance service for the AVRS of 100KVA or above capacity. He should be authorised dealer of Servokon/Stabiline system/Delta Instruments India/any reputed make AVRs. The documentary evidence/proof of experience and authorization certificate must be enclosed with the tender; otherwise the tender shall be out rightly rejected.
- 15. Security deposit of 10% of amount in the form of CDR or FDR issued by any Nationalized Bank, duly pledged in the name of Drawing and Disbursing Officer, Doordarshan Kendra Srinagar will be required to be submitted by the successful bidder for the period of contract.
- 16. The Deputy Director General (E), Doordarshan Kendra Srinagar reserve the right to reject the lowest tender or all the quotations without assigning any reason thereof. The decision of the Deputy Director General (E) will be final.
- 17. The contractor will have to handover all the AVRs in perfect working condition at the end of the contract.
- 18. The tender will be bound to attend the faulty AVR within 24 Hrs. after receipt of telephonic report.
- 19. Penalty will be charged/deducted from dues @ Rs.200/-per day after laps of 24 Hrs.
- 20. The maintenance/repair work will be carried out under the supervision of Engineer In charge.
