



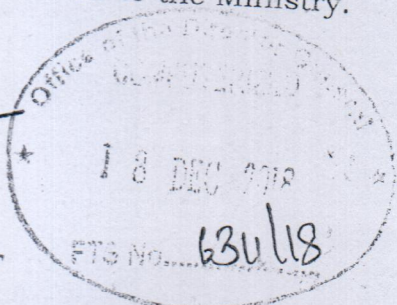
Sir,

I am directed to refer to a VIP reference received from Shri Umashankar Gupta, Hon'ble Minister of Revenue and Science & Technology, Government of Madhya Pradesh regarding posting of an officer of Director level in Doordarshan Kendra, Bhopal. It was sent to DG:DD for comments on 10.11.2017. The officials of DG:DD did not even process the case till 15.02.2018. After a series of reminders dated 01.12.2017 and 23.01.2018, DG:DD vide letter dated 15.02.2018 had informed that they had not received any letters. Thereafter, on 14.03.2018, all papers were sent again by this Ministry to DG:DD. Subsequently, it has been observed that the matter was being shuttled between the DG: Doordarshan and Prasar Bharati and there was no clarity about the domain of the matter. In the process, DG: Doordarshan and Prasar Bharati have taken 9 months in furnishing reply. HMIB has expressed displeasure concern on this delay.

2. In view of the above, it is once again reiterated that the communications received from the Members of Parliament and VIPs should be attended to promptly. Prasar Bharati/DG:All India Radio/DG:Doordarshan are hereby requested to get the system streamlined to take prompt action on VIP references & other important references and ensure that timely replies are furnished to the Ministry.
