# Subject: Introduction of Enhanced Security Layers in the online payment process in PFMS on the recommendation of CERT-IN.

This is in continuation of this office Memorandum No. MF-CGA/ITD/SDTQC/FC/2019-20/138/532-35 dated 26/06/2019, O.M. No. MF-CGA/ITD/SDTQC/SCP/2018-19/122/175 dated 07/05/2019 and O.M. No. MF-CGA/ITD/SDTQC/FC/2019-20/138/650 dated 05/07/2019 regarding Security Advisory in r/o Introduction of Enhanced Security Layers in the online payment process in PFMS.

All Pr. CCAs/CCAs/CAs with independent charges are requested to ensure strict compliance to the following which are being implemented in PFMS on the basis of recommendation of CERT-IN:-

- <u>OTP Based Login</u>: A new feature in PFMS to login with OTP is now developed and being implemented in PFMS from 1<sup>st</sup> September, 2019. All users are now require to update their email ID(GOV/NIC) and mobile no by 31 August, 2019 on PFMS. Going forward any login will now require one-time password (OTP) which is to be sent by PFMS on the registered email ID and mobile number of the user.
- 2. Enforcement of NIC-VPN: The procedure of getting NIC-VPN is already circulated vide this office letter No. MF-CGA/ITD-SPC/2018-19/VPN Connectivity/2652, dated 07-02-2019. The validation regarding NIC-NET/NIC-VPN will be implemented by 15<sup>th</sup> September, 2019 in respect of all treasury users from Pay & Accounts office (DH, AAO, PAO level users), to Pr.AO (DH, AAO, PAO) and CCA level users in PFMS. Beyond the said date no system connected other than NIC-NET & NIC-VPN will be allowed to work on PFMS. Accordingly, action may be initiated for getting NIC-VPN in respect of all the above treasury users as advised in this office O.M. dated 07-02-2019 referred to above.
- Binding of system with IP address: Necessary systemic check of binding the IP address with the treasury users is being enforced in PFMS. All Pr.CCAs/CCAs/CAs are requested to send the list of IP address of all the computers being used by treasury users as indicated above to this office if not already sent.
- 4. <u>Approvals on designated system only:</u> It may be ensured that approval of new accounts shall be carried out by designated officers on designated system only. Accordingly, the concerned approving authority may be apprised about the same. The Controllers may also identify the system for this purpose of approving the respective treasury users. It must be ensured that the approvals in this regard must be given on the said designated system only by the respective Controllers.

5. All Pr.CCAs/CCAS/CAs with independent charge are requested to arrange for enforcement of all these measures in the respected offices before the stipulated timelines. It is re-iterated that these measures have been taken to prevent all kinds of unauthorized intrusions into the IT system of CGA and hence need to be strictly implemented in timely and complete manner
