OFFICE ORDER No. 152/2019-PPC

Consequent upon closure of RABMs as ordered vide DG:AIR's Order bearing No. 13/46/2001-PTT/5 dated 03.01.2019 & No. 13/46/2001-P.III/56 dated 22.02.2019, the following decisions have been arrived at with the approval of the Competent Authority, Prasar Bharati during the meeting held on 09.04.2019 regarding transfer of Assets and records of RABMs:-

2. Other decisions arrived at are:

- i. SMC Lucknow will function from the premises of the erstwhile RABM, Lucknow. SMC, Lucknow will also be responsible for maintenance and security of land. DDO, AIR, Lucknow will also function as DDO for SMC, Lucknow.
- ii. DTI Lucknow to be subsumed with DDK, Lucknow and Head of DDK, Lucknow will function as the Nodal officer for maintaining the records and assets.
- iii. Till such time the transfer orders in respect of Manpower are issued and implemented, the salary and other payment to the officials posted at RABMs may be disbursed from main AIR Station to avoid any hardship to these officials.

3. Accordingly, all concerned are requested to take appropriate action in the matter as per the decision taken in the matter.
