First Appeal dated 31/10/2014 received in this Division on 03/11/2014 Under Section 19(1) of RTI Act, Filed by Ms. Roshini Rohira, 37, Aditya Bungalows, Prem Prakash Ashram, P. Kubernagar, Ahmedabad – 382340.

ORDER

Whereas Ms. Roshini Rohira has sought information under RTI Act – 2005 vide her RTI application dated 03/09/2014 in regards to sexual harassment by Mr. Amul Ahuja, News Reader-Cum-Translator (Sindhi), Ahmedabad which was received in this Division on 15/09/2014 through DG:AIR letter No.04/722/2014/Scor dated 12/09/2014.

1. Sh. Gita Ram, CPIO & Inspector of Accounts, NSD, AIR, New Delhi vide letter No.NSD/AIR/RTI/66/2014 of even No. dated 10/10/2014 had provided the point wise information pertaining to this Division to the Appellant.
2. Whereas the Appellant has filed an appeal to the effect that she has not been satisfied with the reply.
3. Now, therefore, the undersigned has examined the matter with reference to the information sought by the appellant vis-à-vis the reply given by the CPIO/Inspector of Accounts, NSD, AIR, New Delhi.

With regard to point No.2 to 4 & 6 of your RTI application, it is informed that Shri Amul Ahuja, News Reader-cum-Translator (Sindhi) is a Gazetted Group 'B' Officer and DG:AIR is the Cadre Controlling and Competent Authority in respect to News Reader Cum Translator. Therefore, the information of the above points is to be provided by the DG:AIR, New Delhi. As far as NSD, AIR is concerned; no committee has been set up to investigate the complaint of sexual harassment against Shri Amul Ahuja, NRT, Sindhi, AIR, Ahmedabad. A copy of your appeal is being forwarded to S-VIII Section, DG:AIR.

4. The information provided by the CPIO & Inspector of Accounts, NSD, AIR, New Delhi vide letter No.NSD/AIR/RTI/66/2014 of even No. dated 10/10/2014 relating to NSD, AIR is correct.

It is also informed you that you have not remitted the requisite fees of Rs.32/- (Rupees thirty two only) for obtaining the required information in respect to point No.1 & 5 to the CPIO, NSD as informed to you by the CPIO, NSD, AIR, New Delhi vide letter No.NSD/AIR/RTI/66/2014 of even No. dated 10/10/2014 (Copy enclosed). You may, therefore, remit the requisite amount for obtaining the copies of documents from CPIO, NSD, AIR, New Delhi.

5. The appeal is disposed off accordingly.

An appeal against this order can be filed u/s 19(3) of the RTI Act within 90 days from the date of receipt of this order before Central Information Commission, August Kranti Marg, Bhikaji Cama Place, New Delhi – 110066.
