## Subject: Open House Session on issues related to the Programme Cadre in PrasarBharati

4. The nominations should reach on the above mentioned email ID latest by 6 pm on 23<sup>rd</sup> August 2018. The nominations received will be reviewed & scrutinized by a group of officers based on the information as above and 7-8 Groups/ Individuals will be invited to make presentation during the open house session.

5. Attendees including presenters will be from Delhi. However, officials from outside Delhi should try to form Group to prepare their presentation which can be presented by the Group members in Delhi. Technology means may be used as needed so voices and opinions from outside Delhi may also be heard. Specific arrangements needed for the same may be communicated in advance.

6. It is requested that the presentation should be very precise and to the point without spending much time on criticizing system or individuals or historical development. It is expected to hold discussions in a positive environment. The objective is to find practical and workable solutions that address the common greater good of the programme cadre. Individuals/ Groups will be given about 10-15 minutes time each to present their views. The possible workable solutions as an outcome of the open house sessions will be further worked upon by Prasar Bharati for appropriate action and decisions. Based on the learnings of this open house, similar sessions may also be planned to address issues of other cadres and any region/zone specific issues.
