OFFICE MEMORANDUM

Subject:- Payment of remuneration to the contractuels, engaged under the provision of CEP 2012, for the month of April 2020 - regarding.

This is in continuation of Prasar Bharati Sectt. Office Memorandum of even number dated 30.03.2019 on the subject matter.

2. It is hereby stated that the Ministry of Home Affairs(MHA) has issued consolidated revised Guidelines on the measures to be taken for containment of COVID-19 vide their order No.40-3/2020-OM-I(A) dated 15.04.2020 wherein it is mentioned that Lock down has been extended till 3 May 2020 to contain the spread of COVID-19 pandemic in the country.

3. It has been decided by Competent Authority at Prasar Bharati Secretariat that the remuneration for the month of April 2020 may be released to the contractuels of all the Directorates/Verticals, engaged under the provisions of CEP 2012, without any deduction of remuneration on account of no-observation/verification of attendance in the month of April 2020. However if any, discrepancy occurred in due/ drawn of remuneration in the month of March and April, 2020 on account of leave etc if any, the same will be adjusted from the remuneration of subsequent months.

4. It has been further directed that monthly remuneration of all Contractuels of Prasar Bharati, engaged under the provisions of CEP 2012, should be processed and credited to their accounts before 7th of subsequent month which has already communicated vide HR-C letter of even no. dated 15.04.2020.
