2. Information and instructions for bidders posted on web site shall form part of bid document.
3. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website [www.tenderwizard.com/AIR](http://www.tenderwizard.com/AIR) free of cost and also in [www.tenderdetail.com](http://www.tenderdetail.com)
4. Those contractors not registered on the website mentioned above, are required to get registered beforehand.
5. If needed they can be imparted training on online bidding process as per details available on the Website
6. The intending bidder must have valid class-III digital signature to submit the bid.




7. Contractor can up load documents in the form of JPG format and PDF format.
8. Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in yellow colour and the moment rate is entered, it turns green.  
In addition to this, while selecting any of the cells a warning appears that if a any cell is left blank the same shall be treated as "0".  
Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO)
9. The prices quoted by the tenderer shall be firm for the entire contract period. Prices shall be inclusive of all taxes and duties including GST as applicable.

1. Earnest money deposit declaration as per the proforma
2. Valid Electrical License of the contractor/Undertaking that a person with valid Electrical License will be deputed on this work if he is found lowest tenderer. **(Self attested)**

4. Affidavit as per clause 1.2.3 of CPWD-6 duly notarized in **Original** and Name of work to be mentioned above the content of the affidavit
5. Partnership deed (if required) **(Self attested)**
6. Under taking form duly filled and signed by the agency as per page 1 & 2 of CPWD 8.

8. ~~Bank solvency certificate.~~
9. GST Registration certificate as applicable , if already obtained by the bidder alongwith upto date GST return in Annexure-3B (latest) **(Self attested)**


If the bidder has not obtained GST registration as applicable then he shall scan and upload following undertaking along with bid documents.
