1. The Envelopes containing the quotations must be sealed and duly super scribed as 'QUOTATION FOR Supply/ work of Oil Paint, Zinc Chromatic Primer, Painting of Tower'. The Quotations should specifically mention delivery date, make, terms and conditions of supply. **QUOTATIONS NOT PROPERLY SUPERSCRIBED WILL NOT BE CONSIDERED.**
2. **THE COVER SHOULD BE SUPER SCRIBED WITH THE FOLLOWING :**
 - a. Material for which quotations are enclosed.
 - b. Reference to letter of enquiry.
 - c. Due date of opening quotation.
3. The Quotations will be opened in this Office at 04.00 p.m. on 4/2/2019 in the presence of tenderers or their agents, such as they may choose to attend.
4. In case tender opening date falls on a holiday, the bids will be received and opened at the same specified time on next working day. Bid received late or submitted after the scheduled specified time, scheduled date will not be entertained and will be returned back unopened.
5. The price should be firm and given as under:
 - a) The unit price should be for 'UNIT' as indicated in the tender enquiry.
 - b) Price should be F.O.R. Station of dispatch / destination in India & Inclusive of charges for packing forwarding, Octroi etc. where applicable. Octroi exemption certificate will be issued by this Office where necessary.
 - c) The purchaser will not pay separately for transit insurance & you will be responsible for the safe transportation and safe arrival of the stores at destination.
 - d) Printed terms & conditions on the letterheads of tending firms will not be considered as forming part of the tender. Conditions applicable should be specifically stated.
 - e) Complete technical details required as per our specifications shall be furnished along with the quotations, relevant drawings, pamphlet, illustrated literature or photographs may also be sent. The material offered should carry a guarantee for Two year against defects in workmanship & Materials.
 - f) The quotation submitted should remain open for acceptance for period of Three months from the date of opening them.
 - g) Any deviation arising out of revision of quantity of Stores is acceptable to the Tenderer and necessary adjustment in payment will be made based on the quantum of Stores increased or decreased due to such revision.
 - h) The supply of Stores should be co-ordinated through the Representative of DDG(E), HPT, AIR, Bambolim at site.
6. It being a broadcasting studio high degree of accuracy and finishing is required for aesthetic look and to meet technical requirements and must be of Professional Quality having confirmation to India / International approved Standards.
7. **TAXES:-** All taxes where leviable & intended to be claimed from the purchaser should be distinctly shown. Tax not quoted separately will be presumed as inclusive and will not be entertained after acceptance of tender.
8. **RIGHT OF ACCEPTANCE:-** This office reserves the right to reject the lowest tender or any or all the tenders without assigning any reason whatsoever. Further this office reserves to itself the right for decreasing the quantity of materials tendered depending upon actual requirement. The unit rate quoted in the tender should be applicable to the quantity for which order is placed.
9. **TERMS OF PAYMENT;** 100% of payment will be made within 30 days from date of receipt of stores in full & good conditions at the destination or the date of receipt of bill whichever is later.
10. **BILL SUBMISSION;-** The bill may be submitted in duplicate after receipt of the Stores along with the Challan. Payment will be done through ECS by direct credit to bank account through ECS, NEFT, RTGS, Etc.
11. **Quotation submitted should remain open for acceptance for period of three months from the date of opening.**
12. Income Tax @ of 2% of the contract value will be deducted from the bills of successful contract, if the value of contracts awarded during the financial year is more than Rs. 2,00,000/-
13. If the supply is not affected within the stipulated period, this office will impose a penalty of ½% contract value per week or part thereof. If delay exceeds for more than 4 weeks DDG(E), APT, Bambolim will have the right to terminate the contract with you & recover the loss from you.

SPECIFICATIONS FOR PAINTING THE TOWER:

1. Total number of towers : 02 (One)
2. Height : T1. 140 meter./ T3 90mts.
3. All, dust, dirt, grease, etc. must be removed. Base parts must be chipped, wire brushed and dusted and old paints removed as far as possible.
4. No chemicals of any kind are to be used for removal of dust, grease, scales etc.
5. The surface has to be perfectly dry. No dryers like lethargy or turpentine are to be used. The practice of mixing kerosene oil with paints is strictly forbidden. Painting should not be done either in very cold weather or unusually high humidity condition. After thorough cleaning the surface, apply the primer coat. When the primer coat is dry, 2 coats of paint should be applied.

The painting should be done carefully so that all corners of the tower receive the paint. The paint should be evenly and uniformly applied.

The tower should be painted in alternate bands of international orange and white terminating with orange bands at both top and bottom. The width of the white band shall always be one half that of range band.

TERMS & CONDITIONS :

1. The painting should be done as per the specifications detailed above.
2. The paints will be supplied by All India Radio. The contractor will receive the paints and transport to the actual spot without any additional charges, till the work is completed.
3. The daily time schedule for painting the tower will have to be co-ordinated with the station authorities. The specific concurrence of the authorities should be taken before starting the work every time.
4. The time allowed for completion of the work is 20 days from the date the contractor is instructed in writing to commence the work.
5. The contractor should produce an experience certificate in this field before starting the work.
6. He should submit a work mans compensation insurance act policy.
7. All the tools required for the work like scrapping, cleaning, painting etc. of the tower shall be provided by the contractor.
8. Delay in work may result in cancellation of this order.
9. The contractor will be responsible for the safety of workers employed by him.
10. The contractor will be responsible for obtaining proper security passes from the Security Officer of AIR.
11. Unsatisfactory work is likely to be rejected without compensation and AIR will not be financially responsible for such-rejection.
12. Any damage caused by the contractor/workers to AIR property will be recovered from the payment due to the contractor.
13. No labourer below the age of 18 years shall be employed for the work.
14. The contractor should submit the pre-receipted bill in TRIPLICATE. The payment will be made in approximate 30 days time.
15. The work will be started after the monsoon is over.
16. The work should be completed within 30 days on receipt of this office order.
