- 1. Intending bidders
 - (a) Should have satisfactorily completed the works as mentioned below during the last seven years ending last day of the month previous to the one in which the tender is invited.
 - i) Two similar work each of value not less than 60 % of the estimated cost put to tender.

ii) One similar work of value not less than 80 % of the estimated cost put to tender.

The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7 % per annum, calculated from the date of completion to the last date of receipt of application for tender.

- 2. The intending bidder must read the terms and conditions of CPWD-6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
- 3. Information and instructions for bidders posted on website shall form part of bid document.
- 4. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website www.tenderwizard.com/AIR free of cost.
- 5. But the bid can only be submitted after uploading the mandatory scanned documents such as Certificate of work experience/Credential, Demand Draft or Pay order or Banker's Cheque or Deposit at call Receipt or Fixed Deposit Receipts and Bank Guarantee of any Scheduled Bank towards EMD in favor of Executive Engineer (E), Civil Construction Wing, All India Radio, Kolkata Payable at Kolkata and Processing Fee in favour of ITI Limited, Goods & Service Tax registration and other documents as specified.

- 6. Those contractors not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online bidding process as per details available on the website.
- 7. The intending bidder must have valid Class-III digital signature to submit the bid.
- 8. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
- 9. Contractor can upload documents in the form of JPG format and PDF format.
- 10. Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in pink colour and the moment rate is entered, it turns sky blue. In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO).
- 11. SC/ST contractors enlisted under class V category are exempted from processing fee payable to ITI Limited.
- 12. The GST has been implemented by the Government of India with effect from 1st July'2017. The rates quoted by the tenderer shall be firm and inclusive of all taxes including GST and nothing extra shall be payable.
