Reference is invited to PBS Letter No PBS-Audit(19-20)/Misc/221 dated 25.11.19, in the subject mentioned above. Followings are the clarification issued in this regard.

1. Zones can select Audit Coordinator of Zone (ACZ) according to availability of suitable officer from the level of Deputy Director to DDG in the zone/region.
2. The concept of Peer-Audit can be implemented even in absence of exact overlapping of engineering, program & administrative zones/regions in the organization as per attached Annexure-I.
3. All verticals/units which are directly reporting to PB Secretariat are also covered in this system.

However, it is emphasised that all ADG (P)(AIR/DD) have to forward the below mentioned information within 10 days of issue of this letter.

- 1) Periodical Peer Inspection programme
- 2) Name of ACZ & Details of Peer Inspection Team
- 3) Proforma to carry out the inspection.

Thus, all ADGs (P) (Regions) of AIR/DD are requested to take necessary actions as per the above mentioned letter.
