
Please refer to this office letter of even no. dated 05.04.2019 vide which concerned DDOs were requested to submit a certificate in the prescribed Pro forma regarding Status of NPS legacy pendency. Based on the data received from the DDOs a DDO-wise list of pending NPS legacy cases has been prepared (copy enclosed as Annexure-A).

In this connection, it is mentioned that as per the Govt. of India notification bearing file no. 1/3/2016-PR dated 31.01.2019, all such cases where the NPS contribution was deducted but the amount was not remitted to CRA system or was remitted late may be resolved latest by 30.06.2019.

In view of the same, it is requested to take note of the situation and take immediate strict actions to ensure the submission of legacy data of all pending cases by the DDOs (**through the concerned PAOs**) so that the NPS fund transfer process may be completed within a period of next two months in a targeted manner. **DDOs as well as PAOs** may be instructed accordingly to take immediate necessary action.

This may be treated as "**Most Urgent**".
