Subject: Set of Protocol for promotion of Digital Payments in Autonomous Bodies and Public Sector Undertakings (PSUs) of M/o of Information & Broadcasting against the target of 25 Crore total number of digital transactions assigned by Ministry of Electronic & Information Technology (MeitY)-reg.

Reference is invited towards CCA, Pr. AO, M/o I&B's letter No. Pr.AO/I&B/B&A/Dig.Trans./2017-18/321-335 dated 30th May, 2018 on the above mentioned subject.

2. In this connection, it has been observed that in spite of several reminders most of the Head of Kendras/Units are not furnishing the information on promotion of digital payment on monthly basis. The matter has been viewed seriously.

3 Most of the Doordarshan Units has not furnished the information for the month of September, 2020. Head of office of Kendras/Units (list enclosed) who has not furnished the information please explain the reason for non-compliance of Min. of I&B's above mentioned letter dated 30.05.2018 .

4 As all are aware that Government of India is promoting the digital payments system and Prasar Bharati/DG:Doordarshan has already issued instructions to DD Network from time to time. However, it is observed that most of the Doordarshan Field Units are not making all payment activities through the Digital Payment system. It is reiterated that maximum transactions must be done digitally for compliance of Min. of I&B's above mentioned letter dated 30.05.2018.

5. This has been viewed seriously by the Higher Authorities. Heads of Office/DDOs please explain the reason whose digital transaction is less than 50% of total.transaction.

6. Accordingly, all the Head of Kendras/Units are requested to make sincere efforts in all their payment activities for the promotion of digital payments and advised to strictly adhere to the timeline i.e. 5th of following month for the submission of requisite information pertaining to digital transactions as per prescribed format through email at "doordarshandigital@gmail.com".
