G.S.R. 2111.—In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules further to amend the All India Radio (Class III posts) Recruitment Rules, 1964, published with the notification of the Government of India in the Ministry of Information and Broadcasting, No. G.S.R. 1776, dated the 30th November, 1964, namely:—

- (1) These rules may be called the All India Radio (Class III posts) Recruitment (Tenth Amendment) Rules, 1968.

(2) They shall come into force on the date of their publication in the official Gazette.

2. In the Schedule to the All India Radio (Class III posts) Recruitment Rules, 1964 after Serial No. 53 and the entries relating thereto the following shall be added, namely :—

G.S.R. 2112.—In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Notification of Government of India in the Ministry of Information and Broadcasting's No. 3(37)/56-B(P)/B(A), dated the 27th May, 1959, the President hereby makes the following rules further to amend the All India Radio (Class III posts) Recruitment Rules, 1964, published with the notification of the Government of India in the Ministry of Information and Broadcasting, No. G.S.R. 1776, dated the 30th November, 1964, namely :—

1. (1) These rules may be called the All India Radio (Class III posts) Recruitment (Eleventh Amendment) Rules, 1968.

(2) They shall come into force on the date of their publication in the Official Gazette.
