- G.S.R. 1485.—In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules to amend the National Archives of India (Class III Posts) Rules, 1959 published with the notification of the Government of India in the Ministry of Education No. G.S.R. 1148 dated the 17th October, 1959, namely:—
 - 1. These rules may be called the National Archives of India (Class III posts) Amendment Rules, 1965.
 - 2. In the National Archives (Class III posts) Amendment Rules, 1965, after rule 4, the following rule shall be inserted, namely:—
 - "5. Power to relax.—Where the Central Government is of opinion that it is necessary or expedient so to do, it may by order, for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons."

- राष्ट्रीय प्रभिलेखागार (ततीय श्रेणी पद) नियम, में नियम 4 के पश्चात् निम्नलिखित नियम प्रविष्ट किया जायेगा, श्रर्थात्:——

"छूट का श्रधिकार 5:— जहां केन्द्रीय सरकार की राय है कि यह जरूरी है श्रथवा ऐसा करना वांछनीय है, वहां ग्रादेश द्वारा, लिखित में श्रभिलेख के कारणों के लिये, कर्मचारियों की किसी भी श्रेणी या वर्ग के संबंध में इन नियमों की किसी भी व्यवस्था में छूट दी जाये।"
