G.S.R. 615.—In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules further to amend the All India Radio (Class IV Posts) Recruitment Rules, 1964, published with the notification of the Government of India in the Ministry of Information and Broadcasting No. G.S.R. 1777, dated the 30th Noember, 1964, namely :—

1. (i) These rules may be called the All India Radio (Class IV Posts) Recruitment (Second Amendment) Rules, 1968.

(ii) They shall come into force on the date of their publication in the Official Gazette.

2. In the Schedule to the All India Radio (Class IV Posts) Recruitment Rules, 1964, after Serial No. 13 and the entries relating thereto, the following shall be inserted namely :—
