G.S.B. 1352.—In exercise of the powers conferred by the proviso to article 309 of the constitution, the President hereby makes the following rules further to amend the All India Radio (Class I Posts) Recruitment Rules, 1963, published with the notification of the Government of India in the Ministry of Information and Broadcasting No. GSR 24, dated the 23rd December, 1963; namely:—

1. These rules may be called All India Radio (Class I Posts) Recruitment (Amendment) Rules, 1968.

2. In the Schedule to the All India Radio (Class I Posts) Recruitment Rules, 1963, after Serial No. 9 and the entries relating thereto, the following shall be inserted, namely:—
