Qualification - Should have passed CMA Intermediate Examination conducted by Institute of Cost Accountants of India (ICMAI) with at least 60% marks.



Monthly remuneration:- The monthly consolidated stipend fixed for the Cost trainees is as under:-



- b. Similarly, the cost trainee may also leave the organization before the completion of his/her training period by giving an advance notice of one month to the Prasar Bharati.

In case, it has come to the notice of Prasar Bharati that the cost trainee has entered into contract of employment/ training with any other organisation/ employer before the expiry or termination of his contract with Prasar Bharati then his contract of training will be terminated by the Prasar Bharati immediately under intimation to the Institute.


