Monthly remuneration:- The monthly consolidated stipend fixed for the Cost trainees is as under:-



In case, it has come to the notice of Prasar Bharati that the cost trainee has entered into contract of employment/ training with any other organisation/ employer before the expiry or termination of his contract with Prasar Bharati then his contract of training will be terminated by the Prasar Bharati immediately under intimation to the Institute.
- d. The training period of Cost Trainees at Prasar Bharati would be extended for subsequent year based on yearly appraisals.
