

1. **Category: Editor (Sports)**
2. **No. of Position: 1**
3. **Essential Qualification:** Degree or Diploma in Journalism or TV Production from a recognized university/institute.
4. **Desirable Qualification:** Degree in Sports TV Production
5. **Experience:** At least 10 year of experience in Media organization in at a senior position in Sports Reporting or Desk.
6. **Desirable Experience :**
 - (a) Basic knowledge of television production
 - (b) Complete knowledge Sports Coverage and Production.
 - (c) Ability to multi task and generate audio and Video content.
7. **Duration of engagement:** Two Year
8. **Nature of Duties:** Handling production of sports related events and Social Media and Digital work for DD Sports and assisting Channel Manager DD Sports in programme production.
9. **Monthly Remuneration:** Rs.1,10,000/- per month fixed remuneration will be paid (consolidated).
10. **Age:** Below 50 years as on Date of Publishing.
