1. These rules may be called the All India Radio (Class II Posts) Third Amendment Rules, 1962.
2. In the Schedule to the All India Radio (Class II posts) Recruitment Rules, 1962 in Column 11 against Serial No. 1, for the existing 'Note', the following shall be substituted, namely,

Note: 1. “Vacancies against direct recruitment quota to be filled through a written test *cum* interview.

Note: 2. Vacancies against promotion quota to be filled through a departmental test *cum* assessment of reports by the Departmental Promotion Committee.”
