- G.S.R. 1225.—In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules further to amend the All India Radio (Class II Posts) Recruitment Rules, 1962 published with the Notification of the Government of India in the Ministry of Information and Broadcasting No. G.S.R. 347 dated the 6th March, 1962, namely:—
- 1. These rules may be called the All India Radio (Class II Posts) Recruitment Amendment Rules, 1963.
- 2. In the All India Rudio (Class II Posts) Recruitment Rules, 1962, in the Schedule, after Serial No. 6 and the entries relating thereto, the following shall be merted, namely—
