G.S.R. 15.—In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules further to amend the All India Radio (Class 1 Posts) Recruitment Rules, 1963, published with the notification of the Government of India in the Ministry of Information and Broadcasting No. G.S.R. 24, detail the 23rd December 1963, namely:—

- (1) These rules may be called the All India Radio (Class I Posts) Recruitment (Amendment) Rules,
- (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. In the Schedule to the All India Radio (Class I Posts) Recruitment Rules, 1963, against Serial No. 10, for the entries, the following shall be substituted, namely:—
