(रक्षा मंत्रालय को छोड़कर) भारत सरकार के मंत्रालयों और (संघ राज्य क्षेत्र प्रशासनों को छोड़कर) केन्द्रीय प्रधिकारियों द्वारा निधि के अन्तर्गत बनाए ग्रॉर जारी किए गए साधारण नियम जिनमें साधारण प्रकार के खावेश, उपनियम ग्रावि सम्मिलित हैं

सा॰ सा॰ ति॰ 361—राष्ट्रपति, संविधान के अनुच्छेद 309 के परन्तुक द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, मिन्नमंडल सचिवालय में "श्रीडिंग मशीन कौपरेटर" के पद की भर्ती प्रणाली के संबंध में निम्नलिखित नियम बनाते हैं, श्रयात् :---

- 1. संक्षिप्त लाभ और आरम्भ:-(1) इत नियमों का नाम मंत्रिमंडल सचिवालय (श्रींडण मशीन औपरेटर) भर्ती नियम, 1979 है।
 - (2) ये सरकारी राजपत्र में प्रकाशित होने की तारीख से प्रवृत्त होंगे।
- 2. पदों की संख्या, वर्षीकरण और वेतनमान:-- पदों की संख्या, इसका वर्गीकरण और वेतनमान वे होंगे जो संलग्न ग्रनुसूची के कालम 2 से 4 तक में विनिर्दिष्ट हैं।
- 3. भित-प्रणाली, प्रायुसीमा और अन्य ग्रहैताएं :- उक्त पद की भर्ती-प्रणाली, ग्रायु-सीमा श्रहैताएं और उससे संबंधित श्रन्य बातें वे होंगी जो उक्त श्रनुसूची के कालम 5 से 13 तक में विनिद्धिट है :

उपर्युक्त अनुसूची के कालम 6 में निर्धारित आयु-सीमा में छूट दी जा सकती है यदि उम्मीदवार अनुसूचित जाति/अनुसूचित जनजाति और केन्द्रीय सरकार द्वारा समय-समय पर जारी किए गए आदेशों के अनुसार वर्गों से संबंधित है।

RULES

- 1. (1) These rules may be called the Port of New Mangalore (Harbour Craft) Amendment Rules, 1979.
- (2) They shall come into force on the date of their publication in the Official Gazette.
- In the Port of New Mangalore (Harbour Craft) Rules, 1976—
 - (1) in rule 3, for the provisos, the following proviso shall be substituted, namely:—
 - "Provided that nothing in this rule shall apply to-
 - (a) any craft forming part of the equipment of a ship or steamer unless it carries the passengers or cargo for profit;
 - (b) any craft maintained solely for purpose of pleasure and not connected with the carrying of passengers or cargo for profit;
 - (c) any craft belonging to the port";
- (2) for the Explanation under sub-rule (3) of rule 12, the following Explanation shall be substituted, namely:—
 - "Explanation.—For the purpose of this sub-rule, a! the repairs which involve replacement or renewals affecting sea-worthiness of the craft shall be deemed to be major repairs";
- (3) for sub-rule (3) of rule 13, the following sub-rule shall be substituted, namely:—
 - "(3) Every licenced harbour craft plying within the port shall carry as many number of life jackets as there are number of persons including passengers and crew. In addition, craft shall carry life buoys at the rate of one for every two persons including passengers and crew, subject to a minimum of two numbers of life buoys in every harbour craft. Alternatively, in lieu of life buoys buoyant apparatus sufficient to carry the total number of persons including passengers and crew shall be provided. The life buoys and buoyant apparatus shall be of the pattern as approved by the Ministry of Transport";
- (4) in rule 19, the following proviso shall be inserted namely:—
 - "Provided that in the event of a licenced harbour craft being found over-loaded by the Tindal, only those passengers who entered the craft or the quantity of cargo that was loaded after the prescribed limit as specified in the licence, shall be asked to leave or be removed, as the case may be, to confirm with the conditions of the assignment of the issue of licence":
- (5) for rule 25, the following rule shall be substituted namely:-
 - "25. Liability of the owner for the acts of Tindal or any member of the crew employed by him on his craft.—
 The owner of the craft shall be responsible for any acts of Tindal or any other member of the crew employed by him on his craft, while plying the craft under the provisions of these rules";
- (6) for rule 26, the following rule shall be substituted. namely:---
 - "26. Revocation of licences.—If, in the opinion of the Deputy Conservator, the owner of any licensed harbour craft or Tindal or any member of the crew has contravened any of the provisions of these rules, he may, without prejudice to any other action that may be taken against such owner in respect of the contravention, cancel, all or any of the licences helé by the owner";

- (7) after rule 31, the following rule shall be inserted namely:—
- "32. Procedure for imposing penalties.—Every person on whom a charge of breach of any of the provisions under these rules are made shall be given a reasonable opportunity of being heard before any penalty is decided for such offence, and that no order imposing a penalty under these rules shall be made except after giving the person on whom such a penalty is proposed to be imposed a reasonable opportunity of being heard,"

सावकावित 389.—संविधान के अनुच्छेद 309 के परन्तक द्वारा प्रवक्त अधिकारों का प्रयोग करते हुए, राष्ट्रपति, आवाशवाणी समूह 'क' मर्ती नियम, 1963 में और संशोधन करने के निये एतद्हारा निम्म-लिखिन नियम बनाते हैं, अर्थात्:—

- (1) इन नियमों को आकाणवाणी संयूह 'क' भर्ती (रांणीधन)
 नियम, 1979 कहा जायेगा ।
- (2) ये नियम सरकारी राजवत्न में प्रकाशित होने की तारीख को प्रवृक्त होंगे ।
- 2. त्राकाशवाणी समृह के भर्ती निधम, 1963 की ऋनुसूची भें, "निदेशक (सुरक्षा)" के पद से संबंधित क्रम संख्या 22 के सम्मुख,
 - कालम 2 के अन्तर्गत प्रिविष्टि के स्थान पर, "उप महानिदेशक (सुरक्षा)" की प्रविष्टि प्रतिस्थापित की जायेगी;
 - (2) कालम 5 के ऋन्तर्गत प्रविष्टि के स्थान पर ,"2000-125/2-2250 रुपये" की प्रविष्टि प्रतिस्थापित की जायेगी ।

- G.S.R. 389.—In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules further to amend the All India Radio Group 'A' Recruitment Rules, 1963. namely:—
- 1. (1) These rules may be called the All India Radio Group 'A' Recruitment (Amendment) Rules, 1979.
- (2) They shall come into force on the date of their publication in the Official Gazette,
- 2. In the Schedule to the All India Radio Group 'A' Recruitment Rules 1963, against serial number 22, relating to the post of "Director (Security)"—
 - (i) for the entry under column 2, the entry "Deputy Director General (Security)" shall be substituted;
 - (ii) for the entry under column 5, the entry "Rs. 2000-125/2-2250" shall be substituted,
