- 7. Broadcasters desirous of allotment of slot on DD Free Dish are required to provide clear and unambiguous proof in support of genre classification of their channel. In case of lack of clarity, ambiguity or conflicting information, applications will be deemed ineligible and may be summarily rejected. For details please refer checklist of documents provided with the application form.
- 8. Successful bidders shall be required to make the payments in 06 monthly installments as per payment schedule prescribed under clause (5) of the policy guidelines for allotment of DD Free Dish slots. Each installment will be 1/6th of difference of bid amount and participation fee.
- 9. Online training will be provided to all eligible participants before the commencement of actual e-Auction.
