The bid document consisting of plans, specifications, schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from the website <a href="https://prasarbharati.eproc.in/free">https://prasarbharati.eproc.in/free</a> of cost.
- 4. But the bid can only be submitted after depositing Processing Fee in favour of M/s. C1 India Pvt.
