Agenda: Allocation of FM Stations in Clusters

1. Vide this Secretariat's Office Order No 225/2021-PPC dated 04.10.2021 (Annexure I) and subsequent order dated 23.03.2022 (Annexure II), entire field offices of Prasar Bharati has been divided into 80 Clusters to be headed by an officer of the rank of ADG/ DDG/Director to improve the administrative efficiency.

2. A proposal of East Zone has been received from DG:AIR regarding allocation of new FM stations in West Bengal and Odisha. Also, East Zone has also proposed modification in some of the Clusters of West Bengal and Jharkhand.

4. Also, a different Agenda on modification of Clusters was placed before the Management Committee in its 137th meeting (Annexure III). The Agenda placed before the Management Committee consisted different proposals for modification of Clusters. One of the proposals was placing HPT Avadi under AIR Chennai Cluster.

5. In the initial order dated 04.10.2021, wherein Clusters were formed HPT Avadi was omitted and was not placed under any Cluster. Management Committee did not agree to the proposals in the Agenda, hence the proposal of placing Avadi under a Cluster was also not agreed to.

6. In present scenario, HPT Avadi is not under any Cluster. Keeping in view the administrative convenience and uniformity, HPT Avadi should be placed under a Cluster and accordingly, Management Committee may be requested to review its decision and place HPT Avadi under AIR Chennai Cluster.
